This Audition Non-Disclosure Agreement and Materials Release (the “Agreement”) is entered into between Bayou Mystic Films, together with its owners, affiliates, and any production entity it forms for the motion picture presently titled THIRTEEN SACRIFICE and any related or successor projects (collectively, the “Company”), and the individual submitting an audition (“Applicant,” “you,” or “your”). By creating an account, checking the consent box, and submitting an audition, you agree to the following terms.

1. Confidential Materials

In connection with your audition, the Company may provide you with scripts, script excerpts and “sides,” character descriptions, storyboards, artwork, images, casting notices, story and plot details, production plans, and other materials relating to THIRTEEN SACRIFICE and the Company’s other projects (collectively, the “Confidential Materials”). All Confidential Materials are the sole and exclusive property of the Company and are shared with you strictly for the limited purpose of preparing and recording your audition.

2. Your Confidentiality Obligations

You agree that you will:

- Keep all Confidential Materials strictly confidential and not disclose, publish, post, perform publicly, stream, or share them with any person or platform;
- Not copy, reproduce, screenshot, record, forward, or distribute the Confidential Materials except as strictly necessary to record your own audition self-tape;
- Not post any portion of the script, sides, characters, images, story, or plot on social media, video platforms, forums, or any public or private channel;
- Use the Confidential Materials solely to prepare and submit your audition, and for no other purpose whatsoever;
- Permanently delete or destroy all Confidential Materials in your possession upon request by the Company, or once the casting process concludes.

3. No Public Display of the Company’s Material

For the avoidance of doubt, you may not publicly display, exhibit, or “show off” any of the Company’s sides, script, characters, artwork, or other Confidential Materials — including your self-tape to the extent it contains the Company’s copyrighted dialogue or material — on any website, social media account, reel, or public forum, at any time, without the Company’s prior written consent.

4. Ownership of the Company’s Property

Nothing in this Agreement grants you any right, title, license, or interest in the Confidential Materials or in THIRTEEN SACRIFICE. All intellectual property, including the screenplay, characters, and all creative elements, remains the exclusive property of the Company at all times.

5. Release of Your Submitted Materials

By submitting your audition, you grant the Company permission to use the materials you submit — including your name, likeness, image, photographs, video, voice, and biographical information (collectively, “Submission”) — for the limited purposes of reviewing, evaluating, and considering you for casting. You represent that the Submission is your own, that you have the right to submit it, and that it does not infringe the rights of any third party. The Company is under no obligation to cast you, to use your Submission, or to provide compensation or feedback, and participation in this audition does not create any employment relationship or guarantee of any role.

6. No Fees to Audition

No fee of any kind is required to audition. Auditioning for THIRTEEN SACRIFICE, accessing audition sides, and submitting a self-tape are free of charge. No purchase, payment, membership, or other financial contribution is required for, or considered in, the casting process or any casting decision.

7. No Obligation; Independent Development

The Company may be developing or considering similar characters, stories, or materials independently. Nothing you submit obligates the Company in any way, and the Company shall have no liability for using ideas or materials that are similar to any Submission where such use does not rely on your confidential contribution.

8. Term

Your confidentiality obligations under this Agreement begin when you first receive any Confidential Materials and continue indefinitely, surviving the conclusion of the casting process and any decision by the Company.

9. Remedies

You acknowledge that any breach of this Agreement may cause the Company irreparable harm for which monetary damages would be inadequate, and that the Company shall be entitled to seek injunctive relief in addition to any other remedies available at law or in equity, including recovery of reasonable attorneys' fees and costs.

10. General

This Agreement is governed by the laws of the State of Louisiana, without regard to conflict-of-laws principles. If any provision is found unenforceable, the remaining provisions remain in full force. This Agreement is the entire agreement between you and the Company regarding its subject matter and may only be modified in writing by the Company.

By creating an account and checking the consent box, you acknowledge that you have read, understood, and agree to be bound by this Agreement.
